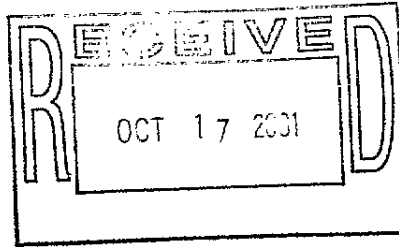

1. Affiant is the President of Technical Options, Inc., an Ohio corporation (hereinafter the "Company"); and

3. The Company does not now maintain, nor has it ever maintained, any business office in the State of Florida; and

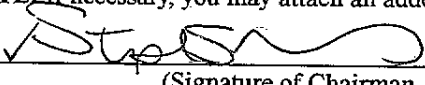

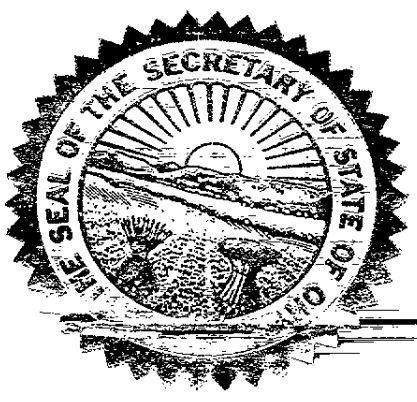
