As we discussed yesterday over the telephone, it is our request that the State waive all fees and penalties related to the subject corporation's failure to obtain a Certificate of Authority to transact business in the State of Florida concurrent with its commencement of business activity in the State, January of 1989.

At the time the company first transacted business in the State, its headquarters were in NY, and Florida business then, as now, was very minimal. It had been my assumption, however, that the requisite paperwork had been filed as part of the normal processes involved with commencing to do business. Obviously, it was not done.

I first became personally aware of the problem last year when we attempted to register the business name under Florida's Fictitious Name provisions and was denied.

Notwithstanding the company's failure to register, it is impossible for the company to absorb the \$12,000 plus in fees and penalties that you are requesting. Although it is my hope that Horizon's East, Inc. will be able to continue to do business within the State, the company would be forced to discontinue all activities here if we are unable to receive an accommodation as requested.

We look forward to the State's forgiveness in this matter and receipt of the appropriate materials for authorization to do business as a Foreign Corporation. Although we are not in a position to assist with the State's funding on a retroactive basis, we certainly are desirous of becoming a good corporate citizen and paying applicable fees and tariffs on a going forward basis.
