

The Hartford Steam Boiler Inspection and Insurance Company of Connecticut ("HSBCT") originally registered to do business in Florida in order to perform inspection services in connection with contracts which had been transferred to it by its parent company, The Hartford Steam Boiler Inspection and Insurance Company on January 1, 2002. On or about the same time HSBCT filed for an insurance license.
