ARTICLES OF DOMESTICATION OF

PDCA INC., PROFESSIONAL DRIVER CARRIER ASSOCIATION



Pursuant to the provisions of Section 16-10a-1533, *Utah Code Annotated*, the undersigned, a natural person over the age of eighteen (18) years, acting as the duly authorized officer of PDCA INC., PROFESSIONAL DRIVER CARRIER ASSOCIATION ("Corporation"), hereby files of record with the State of Utah these Articles of Domestication, which Articles have been duly adopted by the Corporation's Board of Directors and approved by the Corporation's sole shareholder in accordance with the Corporation's by-laws and as otherwise required by applicable law

ARTICLE I Corporate Name

The name of this corporation is "PDCA Inc., Professional Driver Carrier Association".

ARTICLE II Corporate Purposes

The purpose for which this Corporation is organized is to:

- A. Engage in the provision of a broad array of travel goods and services to trucking companies and other highway travelers, including without limitation the provision of, or arrangement for general goods and services, parts, repairs, insurance, and other travel conveniences, at discounted prices for the benefit of its members.

- C. To own, sell, lease, convey, transfer, operate, manage, invest in, and maintain real and personal properties, of every sort and kind, for any purposes deemed to be in the best interest of, or in furtherance of the business purposes of the Corporation,
- D. To do each and every thing necessary, suitable, or proper for the accomplishment of any of the purposes or objects herein enumerated, or which may at any time appear conducive to or expedient for the protection or benefit of the Corporation, and to do said acts as fully and to the same extent as natural principals, agents, partners, trustees or otherwise, either individually, or in conjunction with any other person, partnership, association, joint venture, limited liability company, corporation or other entity recognized in law or equity;

- F To invest and reinvest the assets of the Corporation and to purchase or otherwise acquire, hold, sell, transfer, exchange or otherwise dispose of, or realize upon, investments and securities of all types and descriptions and any other interests in business ventures, and
- G. To transact and engage in any other business, venture or operation, and any and all lawful acts, activities or transactions which a corporation organized under the laws of the State of Utah might do or engage in, even though not expressly stated herein

ARTICLE VIII Capitalization

The aggregate number of shares which the Corporation shall have authority to issue is Twenty-Five Thousand (25,000) shares of voting Common Stock, having a par value of One Dollar (\$1 00) per share Each share of issued Common Stock shall entitle the holder thereof to one (1) vote on each matter submitted to a vote at a meeting of the shareholders. All stock of the Corporation shall be of the same class and shall have the same rights and preferences. The capital stock of the Corporation shall be issued as fully paid, and the private property of the shareholders shall not be liable for the debts, obligations, or liabilities of the Corporation. Fully paid stock of this Corporation shall not be liable to any further call or assessment.

ARTICLE IX <u>Directors</u>

The Corporation shall be governed by a Board of Directors elected and governed by the by-laws of the Corporation

ARTICLE X By-Laws

The Corporation has, and shall at all times hereafter establish and maintain by-laws which are not inconsistent with law or these Articles for the regulation and management of the affairs of the Corporation.

Such indemnification shall be in addition to any other rights to which those indemnified may be entitled under any law, bylaw, agreement, vote of stockholders, or otherwise.

Except as otherwise prohibited by law, no Director or Officer shall be personally liable to the Corporation or its shareholders for monetary damages for breach of fiduciary duty, except for a breach of the Director's or Officer's duty of loyalty to the corporation or its shareholders, or for acts or omissions not in good faith, or for intentional misconduct or intentional violation of law.
