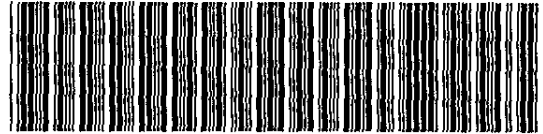

SECOND: The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the DC NCA:


Article First is hereby amended in its entirety to read as follows:


