Dear Mr. Mays:

Thank you for your courtesy during your telephone conversation of December 20, 2001 with Mrs. Martha Mandel.

As discussed, Mandel Resources Corp. Inc., an Illinois corporation, relocated its business activity to Delray Beach, Florida in January of 2000. At that time, telephone inquiry was made to the Florida Department of Revenue as to what document filings, if any, were required by the State of Florida consequential to this move. Unfortunately, we were not informed as to the existence or requirements of Florida Statutes 607.1502 or 608.502.

In any event, a reading of the exemptions under 607.1501 (2) indicates that Mandel Resources Corporation, (MRC) is entitled to exoneration from the filing requirement for the period in question for the following reasons:

- 1. During the relevant period, MRC entered into but a single new business transaction, a consulting contract executed on behalf of Maple Line Holding Corp., a Panamanian Corporation, by its agent, Maritime Brokers and Consultants Inc. of Northbrook, Illinois. Since execution of such contract occured in Illinois and was subject to and approved by its principal managing owner in Athens, Greece, it should qualify for exemption under subsection 2(f).
- 2. Because this was a business transaction completed in interstate commerce, it should qualify for exemption under subsection 2(i).
- 3. Because this was an isolated transaction completed within 30 days and not one in the course of repeated transactions of a like nature, it should qualify for exemption under subsection 2(j).

The sole other business activity of Mandel Resources Corporation consists of administering the collection and distribution of minor oil and gas revenues to partners of three Illinois limited partnerships. With the exception of Mrs. Mandel and myself, none of these partners is a Florida resident and these transactions involve no communication with Florida residents. The relevant revenues are earned from properties located entirely outside of Florida and appropriate filings are made and taxes paid in such states.

For the above reasons, we request an abatement of the penalties set forth in the above referenced communications.

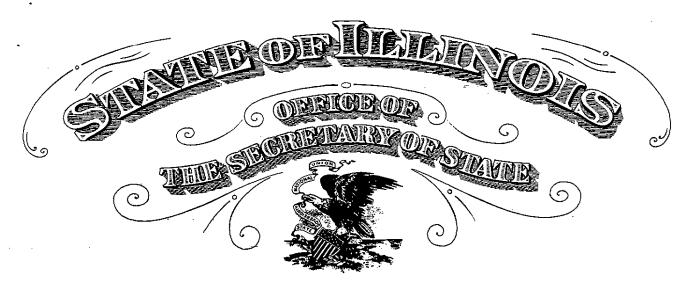
