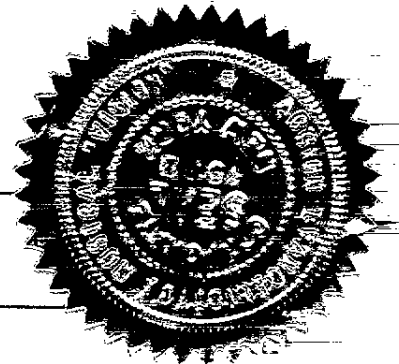

OF
ACCION EVANGELISTICA Y MUSICAL VISION
(VISION EVANGELISTIC AND MUSICAL ACTION)

(PURSUANT TO ARTICLE 10 OF SECTIONS 192 & 193 OF REL. CORP. LAW.)

We, the undersigned, all of full age, American citizens of the United States of North America, resident of the State of New York, for the purpose of founding, continuing, incorporating Accion Evangelistica Y Musical Vision, churches, and unincorporated church, pursuant to Article 10 of the Religious Corporation Law, hereby certify as follows:-----

First:-A notice of the meeting of the members of the "Accion Evangelistica y Musical Vision" to determine whether association should be incorporated, was DULY given pursuant of sections 192 and 193 of the Religious Corporation Law, and such meeting was DULY HELD in accordance therewith on the 10th day of January 1992 at 7:PM in the evening of said day, location at 366 Broome St. Apt 22 county of Manhattan, City and State of New York. -----

Second:-That the Reverend Issac Calle was the presiding officer and spiritual leader, Mr. Pablo Albazarrin, Mr. Rafael Cuzco, Mrs. Daisy Ramos, Mrs. Aurora Campoverde and Mr. Julio Quito.

Third:- That at such meeting it was determined to incorporate such association "Accion Evangelistica y Musical Vision" as a Religious Corporation pursuant to Art. 10 of Sections 192 and 193 of the Religious Corporation Law.-----

Fourth:-The name of the proposed corporation as decided upon by such meeting is: "Accion Evangelistica y Musical Vision".-----

Fifth:- The main office and the principal worship place of such corporation is located at: 366 Broome St. New York, New York 10013.

Sixth:- The number of trustees decided upon at such meeting was three (3).-----

Seventh:-The name of the trustees Duly elected at such meeting to hold office until the first annual election are respectively as follows:-Rev. Issac S. Calle, Mr. Pablo Albarracin and Mr. Rafael Cuzco and elected to hold office until the Second annual Election and Mr. Calle to hold office until the Third annual Election. Nineth:- The objects for which this corporation is to be formed are:-----

(a) To establish and maintain a place or places for religious worship, rehabilitation, prayer and for preaching the FULL GOSPEL OF JESUS- CHRIST and to teach the HOLY SCRIPTURES. To present RADIAL PROGRAMS IN THE AIR and T.V., to conduct and maintain services for divine worship and religious observance and in particular the christian word to human rehabilitation.

(b) To acquire property for associate houses, church buildings, chapels, mission houses, school-houses for Sunday or Parochial school, property for the residence of its ministers, teachers, nurses, or property for a home for the age, or alcoholic or drug addicted.-----

(c) To take and hold any grant, donation bequest, or devise of real or personal property governmental or otherwise heretofore or hereafter made upon trust, and apply the same, or the income thereof, under the direction of the Trustees or other officers, for the purpose of establishing, maintaining and managing as such religious corporation property.

(d) To have power to solicit and raise funds by any and all proper and appropriate means, under and subject to the Religious Corporation Law, and to receive and disburse such funds or money occurring from tithes, offering, collections or any other contributions for the general support of such "ACCION EVANGELISTICA y MUSICAL VISION" corporation.-----

(e) To have power to take, purchase, lease or otherwise acquire real estate, and to hold, own, sell, mortgage, lease or otherwise dispose of same, subject to the provision of the Religious Corporation Law and the General Corporation Law, and to build, construct, maintain, alter and manage any building or buildings, or church edifice for the uses or purposes of said corporation.

(f) To have power to acquire, maintain and improve, real property, to be used as camp ground to meeting purposes. To lead men and women and every body to Jesus-Christ according to the Holy Bible and to save and deliver souls regardless of race color or creed. And to establish, maintain and operate, Day care center, orphanages, homes for the Aged and all other facilities necessary to aid the general public, accordance to worship. To visit correctional facilities etc..etc.-----

(g) To engage in world-wide missionary work, ordain our ministers, Pastors, exhorters, evangelists and the training of missionary workers to teach the tenets of worship as foresaid, anywhere in the United States or outside.

The foregoing clauses shall be construed both as objects and powers and it is hereby expressly provided that the foregoing enumerations of specific powers shall not be construed or held to limit or restrict in any manner the power of the within corporation.

Tenth:-In the event of the dissolution of the corporation its properties shall be distributed only to such Non-profit organizations as are exempt under section 501 as






