It was our understanding that only corporations had to apply to the Florida Secretary of State and not husband and wife partnerships. When I filled out the form "Application by Foreign Corporation for Authorization to Transact Business in Florida", item #6 asks for the date we first transacted business in Florida. I didn't realize that #6 was really asking when was the first date we did business in Florida as a <u>corporation</u>. The correct answer should have been "upon approval for corporation".

I wrote under #6: September 22, 1999 as Ramey Wine Cellars, husband and Repartnership because we had done business in Florida but certainly not as a comperation. Thank you in advance for your help in straightening out this misunderstanding Should you require any other information, please let me know.

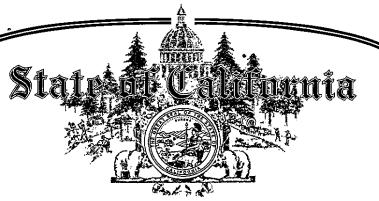
