2. Article I of the Articles of Incorporation of the Corporation is hereby afterded to read as follows:

The Name of the Company shall be Pony Express U.S.A., Inc.

3. Article VI of the Articles of Incorporation of the Corporation as hereby amended to read as follows:

The total number of shares of Common Stock which this Corporation is authorized to issue is 100,000,000 shares at \$.001 par value per share.

4. The foregoing amendments were adopted by all of the Directors and a majority of the Stockholders of the Corporation eligible to vote by a Written Consent signed by them on June 30, 2002, manifesting their intention that these amendments to the Articles of Incorporation be adopted, pursuant to Section 78.385, Nevada Statutes. The number of votes cast for the amendment was sufficient for approval by the Stockholder(s).
