To Whom It May Concern:

I have enclosed a Corporate Reinstatement application, together with a check in the amount of three hundred (\$300.00) dollars; covering the 2003 and 2004 annual report fees.

I am requesting that the reinstatement fee be waived for the following reasons:

(i) We were informed that the Annual Report notice was mailed to an old principal address in New York that we no longer utilize. (The mail was never forwarded to us). Knowing that the NY address on file with the Florida Division of Corporation would no longer be valid, we filed a Statement of Change of Registered Office Or Registered Agent listing a valid address on May 19, 2003. (A copy of this change is enclosed.)

(ii) We thought, incorrectly, that the Annual Report filing request would have been mailed to our updated Florida registered agent, and not the (outdated) principle address. We did not realize this error until it was too late. We also note that we could not find a downloadable form on the sunbiz.org web site that would enable us to change the Principal Address. We found forms that only enabled us to update the registered agent; thus we felt that this change would suffice and that all Florida Department of State related correspondences would indeed be mail to our Florida registered office.

We did not knowingly avoid paying the filing fees and we ask for a waiver of any penalties.
