Enclosed is an Application by Foreign Corporation for Authorization to Transact Business in Florida for OD Aviation, Inc., a wholly owned subsidiary of Office Depot, Inc.

The corporation was incorporated in Delaware in December 1998 and began operating effective January 1, 1999. The necessary registration documents were filed with the Department of Revenue on 12/31/98. The documents for qualification with the Secretary of State's office were completed but apparently never filed due to inadvertence. The corporation was unaware of this inconsistency until now. 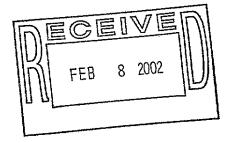

Accordingly, an amount of \$3450.00 is due, reflecting annual report fees of \$450.00 and statutory penalties of \$3000.00. We would, however, offer to settle the issue of annual report fees and foreign non-qualified penalties from OD Aviation, Inc., for the sum of \$1950.00, reflecting annual report fees from 1999 of

\$450.00 and penalties from 1999 of \$1500.00 assessed at the statutory minimum of \$500.00 per year. This offer remains in effect until March 29, 2002.
