CERTIFICATE OF INCORPORATION

OF

RESTORATION CHRISTIAN FELLOWSHIP, INCORPORATED

Pursuant to Article 10 of the Religious Corporation Law

WE, THE UNDERSIGNED, all being persons of full age, whom at least two-thirds are citizens of the United States, and at least one a resident of the State of New York, for the purpose of incorporating an unincorporated, "Non-Denominational", Evangelical Church, pursuant to Article 10 of the Religious Corporations Law, do hereby certify as follows:

**FIRST:** A meeting of the RESTORATION CHRISTIAN FELLOWSHIP, an unincorporated, "Non-Denominational", Church, was duly called and held in conformity with the aforesaid Article of the Religious Corporations Law, at its usual place of worship, 56 Beaver Street, New York, New York, on the 4th day of May, 1986, at 12:30 P.M., in the After noon of said day, at which meeting a majority of the duly qualified voters of said Church, being at least six in number were present.

**SECOND:** At a second meeting, from the qualified voters present, Stepnen Moscard, one of the subscribers herein, was duly elected Clerk, and Carmen Boney and John M. Boney, the other subscribers hereto, were duly elected as inspectors of election.

**THIRD:** At said meeting, it was duly decided that said Church should become incorporated.

**FOURTH:** The name of the proposed corporation, as decided on at said meeting is to be: RESTORATION CHRISTIAN FELLOWSHIP, INCORPORATED.

**FIFTH:** That the particular objects or purposes for which said corporation is formed are as follows, to wit:

- (a) To reveal expound and propagate the Gospel of Jesus Christ according to Holy scriptures.
- (b) To propose the Gospel of the kingdom to all nations.
- (c) To equip and lead the people in the way of salvation, Goodness, Righteousness, Morality and Temperance as taught in the Bible.
- (d) To seek to provide food, shelter and care for God's people both locally and elsewhere.
- (e) To seek by all means to prepare for maturity and unity the body of Christ through diverse ministries (Ephesians 4:11) for the events preceding and also specifically for the return of Christ into this world; this shall be done by the Holy Ghost and the

- (g) To have the power to take and hold any grant, donation, gift, bequest or devised of real or personal property.
- (h) To have power to solicit and raise funds by any and all proper and appropriate means under the subject to the Religious Corporations Law, and to receive and disperse such finds or money accruing from tithes, offerings, collections or any other contributions for the general support of said corporation.
- (i) To have power to take, purchase, lease or otherwise acquire real estate, and to hold, own, sell, mortgage, lease or otherwise dispose of same subject to the provisions of the Religious Corporations Law and the General Corporations Law, and to build, construct, maintain, alter and manage any building or buildings, or Church edifice for the uses or purposes of said Corporation.

**SIXTH:** The foregoing clauses shall be construed both as objects and powers, and it is hereby expressly provided that the foregoing enumeration of specific powers shall not be construed or held to limit or restrict in any manner the powers of the within Corporation.

**SEVENTH:** The number of Trustees thereof shall be six (6), and the number of Church officers shall be three (3), which shall include a President, Secretary, and Treasurer.

**EIGHTH:** The first annual election of the Trustees and Church officers shall be held on the first Sunday in June of 1986, and the annual election of Trustees shall be held each year thereafter on the first Sunday of June.

**NINTH:** The names of the persons elected as Trustees and the terms of office for which they were respectively elected are as follows:

- (I) Egbert Batchelor, residing at 1650 Selwyn Avenue, Bronx, NY 10457 to hold office until the second annual election of Trustees thereafter.
- (II) Robert Lence, residing at 110-45 Queens Blvd., Forest Hills, NY 11375 to hold office until the second annual election of Trustees thereafter.
- (III) Richard S. Routie, residing at 1138 Rogers Ave., Brooklyn, NY 11226 to hold office until the second annual election of Trustees thereafter.
- (IV) John Boney, residing at 963 Camelot Drive, Crystal Lake, IL 60014 to hold office until the first annual election of Trustees thereafter.
- (V) Carmen Boney, residing at 963 Camelet Drive, Crystal Lake, IL 60014 to hold office until the first annual election of Trustees thereafter.
- (VI) Stephen Moscardini, residing at at 963 Camelet Drive, Crystal Lake, IL 60014 to hold office until the first annual election of Trustees thereafter.

TWELFTH: In the event of the dissolution of the Corporation, its property shall be distributed only to such non-profit organizations as are exempt under Section 501, as described in Section 501 (3) of the Internal Revenue Code, as the members of the Corporation shall determine, and subsequent to the approval of a Justice of the Supreme Court of the State of New York. But in no event shall any of its property be distributed to any member or officer of the Corporation.
