In answer to your letter of February 12, (enclosed).

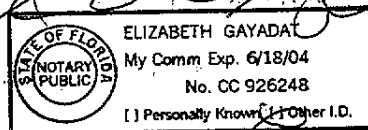

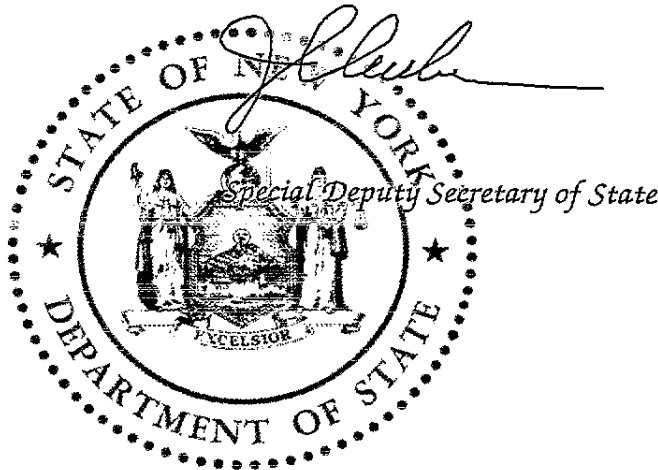
