

I am writing you in response to your letter number 102A00020164 stating Boston Financial Inc. is to pay a penalty of \$1,150 for not being a registered foreign profit corporation to transact business in Florida for the year it began operations in the state.

The reason for not being registered is a miscommunication or misunderstanding of your requirements. After speaking to one of your representative we were informed we could download the forms off your web site needed to comply. We downloaded the forms that your representative said would be required, completed them and sent in the fee amount. When we realized that registration had expired we went back to your web site downloaded the forms and reapplied. Then we received your letter informing us of the penalty. What has happened is that we were either misinformed or confused on what forms to download and sent in the wrong forms on the first registration, then when we reapplied we downloaded and sent in the correct forms.

Do to the fact in good faith attempted to and believed we had complied with your requirements to do business in Florida and was either misinformed or confused about which forms to send in, request that you wave the penalties and qualify us to do business in the state of Florida.
