DESCRIPTION OF ORGANIZATION

11. Brief statement of the organizational purpose.

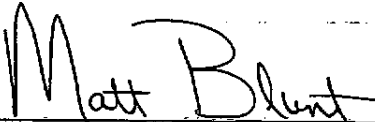
