

We need to resolve this issue in the most expeditious manner possible. Per my conversation with you several months ago, The sanitary sewer company referred to in this correspondence has been operating in Florida for 20 years now. During that period of time it has and continues to operate as a sole proprietorship, owned by Mr. Leslie Tassel.

Mr. Tassel has extensive business interest in the state of Florida with homes both in Florida and Michigan. In an effort to incorporate some of his business interest in Florida, Mr. Tassel requested his Michigan attorney to set up a Florida corporation for the sewer company. Through some miscommunication, the attorney set up a Michigan corporation then further complicated the issue by requesting an application by a foreign corporation for authorization to transact business in Florida.

As the accountants for Mr. Tassel here in Florida, I spoke to the Florida Dept of State Division of Corporations and explained the situation to them. They told me to let the request by the foreign corporation died. As there has been no business or tax returns filed by that corporation, and as the sewer company has been filed and continues to file as a sole proprietorship then the entire issue as to that Michigan company becomes a mute point as far as Florida is concerned.

Furthermore, the Department instructed me to file new Florida corporation papers for the sewer company to resolve the issue. This should have been the original procedure. You are now holding those documents in your possession. This appears to be an innocent misunderstanding that has taken on a life of its own.

Corporation wishes to be qualified to do business in the State of Florida. Accordingly, it is recommended that corporation be issued a certificate of authority.


