



Dear Sir / Madam:

This letter is in regards to our recent submittal to the Registration Section for Division of Corporations under Pavement Savers, Inc. Pavement Savers, Inc. has been doing business all over the U.S. for several years out of the State of Michigan where the main office is located and where our vehicles remain licensed. We are a sales office that has located ourselves in Cocoa, Florida.

For your information, though we have been in Florida since October of 1999, we have done very little business equaling a total of about two months in 2000, two months in 2001 and two months in 2002 to date. All of this was work done as a sub-contractor under a general contractor who had to supply a performance bond and proper insurance as of this date there has never been any work done for a private Company or residential.

Upon beginning our business in October of 1999, we promptly applied for our Occupational licenses and were told that we may need to be licensed through the State of Florida for pavement work. We immediately contacted The State of Florida Licensing and asked what licenses we needed to conduct our line of business. We were told that there is no such licensing for paving contractors. Not only were we told this by your office but were also told this by a broker that handles this type of paperwork.

Based on this information we were under the understanding that we were in fact conducting business, as we should. We were told that because our main office is located in Michigan and the fact that we did our banking in Michigan, we did not need to register with the State of Florida.

When renewing our Brevard County Occupational license in 2001, we had asked them to just place Pavement Savers, Inc. on the license with out my name Patrick O'Connor. Again we ran into the same issue. Brevard County stated that they could not do this unless they had the License from the State of Florida showing Pavement Savers, Inc as the name of the Company. We were also told that our letter from Michigan was not valid to make this change. However ever since we moved our sales office in 1999 we have always had an occupational license with the City of Cocoa, see the enclosed copy.

Needless to say after all the phone calls to the State and Brevard County, we finally spoke with an individual that told us what everyone was requesting and was more than helpful in explaining what we needed this was in March of 2002. She also sent out the Booklet and applications we needed to process this paperwork.

Normally, I would agree that any business that does not try to comply purposely should be penalized, however we have tried on more than one occasion to obtain the information we needed to do business in the State of Florida. If we would have been given the appropriate information the first few times we had called, even if we contacted a different department, we would have had what we requested in 1999.

In conclusion, there has always been a good faith effort by Pavement Savers, Inc to comply with any regulation required that apply as of this date. There has never been a notification by any government agency that we were in non-conformance. It has always been our effort all of this time to comply. Due to this fact I respectfully ask that any penalty be reconsidered.




