

**DECLARATION OF INTENT TO REDOMESTICATE** 

AND AMENDED AND RESTATED

ARTICLES OF

**INCORPORATION OF** 

WATFORD INSURANCE COMPANY

We, the undersigned directors of Watford Insurance Company, a New Jersey corporation, being natural persons over the age of eighteen (18), and constituting the entire board of directors of such corporation, do hereby state our intention to redomesticate Watford Insurance Company to the State of Missouri as a stock property and casualty insurance corporation in the manner provided in and pursuant to section 375.908, RSMo. and the regulations promulgated pursuant thereto, by amending and restating the articles of incorporation of Watford Insurance Company to comply with the requirements of sections 379.010 to 379.065 of the Missouri Insurance Code and

RSMo section 351.106.

The Amended and Restated Articles of Incorporation of Watford Insurance Company set forth below and made a part of this Declaration of Intent to Redomesticate have been approved. respectively, by the sole shareholder and by the board of directors of Watford Insurance Company.

ARTICLE ONE Name

The name of the Corporation shall be Watford Insurance Company.

### ARTICLE TWO Date of Incorporation

The Corporation shall continue its corporate existence without interruption as a corporation from its original date of incorporation on June 4, 1987.

# ARTICLE THREE <u>Duration</u>

The duration of the Corporation is perpetual.

# ARTICLE FOUR Principal Office and Registered Agent

The principal place of business of the Corporation in Missouri shall be 2345 Grand Boulevard, Suite 900, Kansas City, Missouri 64108. The executive and administrative office of the Corporation shall be within or without the State of Missouri as designated by its Board of Directors.

The registered agent of the Corporation shall be CSC-Lawyers Incorporating Service Company. The street address of the registered agent is 221 Bolivar Street, Jefferson City, Missouri 65101.

## ARTICLE FIVE Power and Purpose

The Company shall have the power and authority necessary and incidental to carry out its corporate purposes and in addition, shall have all the powers and authority granted to like property and casualty stock insurance corporations as authorized under Chapter 379 et. seq. RSMO as amended and other applicable laws of the State of Missouri as currently provided, or as may be provided by subsequent legislative acts.

The Corporation shall have the power and authority to engage in any lawful act or activity for which corporations may be organized under Chapter 351 of the General and Business

i.

Corporation Law of Missouri to the extent the same are not inconsistent with or in conflict with sections 379.010 to 379.065 of the Missouri Insurance Code.

# ARTICLE SIX <u>Authorized Shares</u>

The Corporation shall have authority to issue twenty million (20,000,000) shares of capital stock consisting of common stock only, with a par value of one dollar (\$1.00) per share, any part of which shall be issued in such manner as the board of directors may declare and as permitted by law. Four million five hundred thousand (4,500,000) shares of Common Stock have been issued and are outstanding and fully paid up, amounting to four million five hundred thousand dollars (\$4,500,000) in aggregate capital. These Articles do not effect an exchange, reclassification, or cancellation of issued shares, not do they effect a change in the amount of stated capital of the Corporation.

The Corporation has, and shall maintain, paid-in capital and surplus in excess of the minimum amounts required pursuant to Missouri Insurance Code Section 379.010 to transact the lines of insurance for which it is authorized.

### ARTICLE SEVEN Corporate Authority

The Corporate powers of the Corporation shall be vested in a Board of Directors and shall be exercised by the Board and through such officers, agents, employees, and committees, as the Board may, in its discretion, from time to time designate and empower.

The Board shall have the power from time to time to make, amend, or repeal such by-laws, rules, and regulations for the transaction of the business of the Corporation as the Board may deem expedient and as are not inconsistent with these Articles of Incorporation or the constitution or other laws of the State of Missouri.

# ARTICLE EIGHT <u>Directors</u>

The Board of Directors of the Corporation shall consist of not less than nine (9), and not more than twenty-five (25), directors, elected as provided in the by-laws of the Corporation. Meetings of the Board of Directors shall be held as such time and place, and upon such notice, as shall be prescribed by the by-laws of the Corporation.

# ARTICLE NINE Limitation of Liability and Indemnification of Officers and Directors

The liability of the directors of the Corporation shall be limited to the fullest extent permitted by Missouri law as currently provided, or as may be provided by subsequent legislative acts. The Corporation shall indemnify the officers and directors of the Corporation from any liability incurred by them to the fullest extent permitted by Missouri law as currently provided, or as may be provided by subsequent legislative acts.
