



# ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF MORGAN CHASE TRUST COMPANY

The name of the corporation is Morgan Chase Trust Company.

2. The following amendments of the Articles of Incorporation, to be effective January 1, 2006, were adopted by the directors and duly approved by the shareholders on December 22, 2005, in the manner prescribed by the South Dakota Business Corporation Act:

### ARTICLE I.

The name of the corporation is First Capital Surety & Trust Company.

#### ARTICLE V.

The amount of the capital stock of the corporation shall be Two Hundred Thousand Dollars (\$200,000.00) and the aggregate number of shares which the corporation shall be authorized to issue is 8,000 shares, divided into the following classes of stock: 4,000 shares of common voting stock with a par value of Twenty-five Dollars (\$25.00) per share, and 4,000 shares of common non-voting stock with a par value of Twenty-five Dollars (\$25.00) per share.
