UNANIMOUS WRITTEN CONSENT OF THE BOARD OF DIRECTORS OF

MEDALLION FINANCIAL CORP.



The undersigned, being all the Directors of MEDALLION FINANCIAL CORP., a Delaware corporation (the "Corporation"), do hereby unanimously consent, pursuant to Section 141(f) of the Delaware Business Corporation Law, to the adoption of the following resolutions and that such action be taken without a meeting pursuant to said Section 141(f), which consent may be executed in any number of counterparts.

WHEREAS, it is in the best interests of the Corporation that it be qualified to transact business in the State of Florida; and

WHEREAS, the name "Medallion Financial Corp." is not available for use in Florida; and

WHEREAS a proposed \$250 million (maximum available amount) revolving credit facility to be arranged by and among Medallion Funding Corp. ("Funding") and one or more of its affiliates and Merrill Lynch Bank USA and/or one or more of its affiliates has been presented to Funding for the purpose of financing Medallion Loans, such loans being loans that finance and are secured by taxicab licenses, known as "Medallions" (the "Proposed Financing"); and

WHEREAS, the Corporation and Funding intend to exchange Medallion Loans, from the Corporation, and commercial loans, from Funding, in connection with the Proposed Financing and Funding intends to transfer such Medallion Loans to Taxi Medallion Loan Trust I, a Delaware business trust.

NOW, THEREFORE, BE IT

RESOLVED, that the name "Medallion Financial Delaware Corp." is hereby approved for use in Florida; and
