#### Exhibit "B"

To own, hold, build, construct and erect, buildings and structures of all types, and to buy, sell, lease, own, manage operate, maintain, repair, restore and rebuild the same;

To buy or otherwise acquire, to own, hold, to lease, to sell or otherwise dispose of, to mortgage or otherwise encumber, real property and personal property of all kinds, and to operate, manage and maintain the same.

To transport, convey and deliver, as a private carrier, all kinds and character of commodities, for the company or for others, and to do all things necessary, convenient or incidental thereto;

To borrow money and for such purposes to execute notes, bonds, debentures or any other form of evidence of indebtedness, and to secure the payment of the same by mortgage, deed of trust or other form of encumbrance, pledge or other from of hypothecation;

To execute deeds, mortgages, deeds of trust, contracts and other types of written instruments;

To purchase, acquire, own, hold, sell, assign, transfer or otherwise dispose of, mortgage, pledge or otherwise encumber, shares of stock of this company or of any other corporation or corporations of this state, or any other state, county, nation or government, or any interest therein, and while owner thereof to exercise all rights, powers and privileges or ownership pertaining thereto;

To loan or otherwise invest its funds, from time to time, secured or unsecured, for such time and upon such terms and conditions as its Board of Directors may authorize;
