I am in receipt of your June 12, 2002 letter. Mr. Freeman has been handling the business license issue on behalf of DryTech for me. DryTech is my client in most matters.

I have contacted Mr. Franks, the sole shareholder of DryTech, regarding your letter. Mr. Franks informed me that the only time that DryTech was in Florida prior to 2001 was in 1992 when his company did work to remediate water damage after Hurricane Andrew. DryTech is a business which handles water damage after storms, etc. The next time that DryTech was in fact in Florida began in April of 2001 when DryTech attempted to open an office near Cotton Creek, Florida. The gentleman who was operating the office was supposed to have taken care of all the appropriate licensure issues, but did not . Mr. Franks has closed that adjunct office in Florida. The office was closed at the end of 2001.

Mr. Franks is aware of this problem now, and asks you to review the penalty issue. A check will be forthcoming for the correct amount of penalties and fees necessary.


