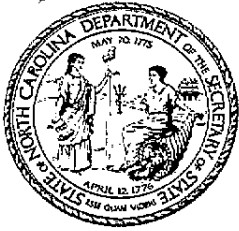

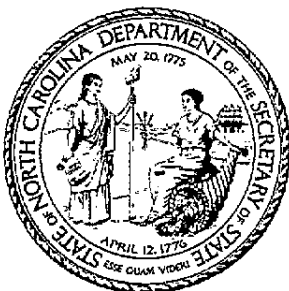
### CERTIFICATE OF EXISTENCE
