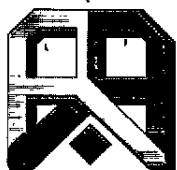


At the advice of someone in your office I spoke to today I am writing this letter requesting relief from the penalty assessed in your letter (copy attached). The circumstances surrounding the matter I thought might be significant enough to warrant a reduction or deletion of the imposed penalty.

We are experienced in hotel renovation. We were hired to go to southwest Florida to work with a local contractor on a major hotel renovation. We were working out the details of our joint venture between our two attorney groups and finally accomplished that where we would actually buy into their established company. Less than 30 days after ironing that all out we were terminated from the project. We didn't even have enough time to register ourselves with you folks before we were gone.

That wouldn't have been a problem obviously, except we have been negotiating to try and recoup the money that is owed us by the developer. The lack of progress on that subject has now led us to unfortunately prepare the filing of a complaint and taking the matter to court. For that reason we need to be now registered with you.

I was hoping that once you or your counsel considered the unusual circumstances the penalty might be waived in this case. Thank you for your consideration of this matter. I look forward to your response.

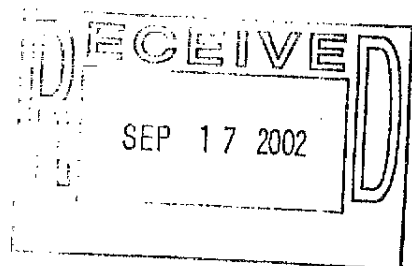

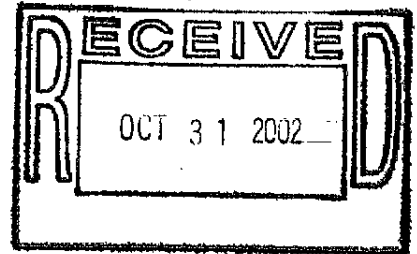


