We have received your document for SENG TIRE, INC. and your check(s) totaling \$87.50. However, the document has not been filed and is being retained in this office for the following:

Based upon information provided by the Florida Department of Revenue, pursuant to section 213.053(14), Florida Statutes, it appears that SENG TIRE, INC. has transacted business in Florida prior to submitting an "Application for Authority to Transact Business in Florida". The information received from the Florida Department of Revenue indicates January 1, 1998, as the initial date of transacting business in the State of Florida.

Pursuant to section 607.1502(4), 617.1502(4) or 608.502(4), Florida Statutes, this office collects a civil penalty of \$1000 for each year this entity transacted business or conducted its affairs in Florida prior to qualification and the appropriate annual report fees that would have been due this office had the entity qualified the year it began operations in this state. The amount due this office to cover both annual report/uniform business report and penalty fees is \$3450.00.

Dear Ms. Seng:

The following is in response to your letter dated November 15, 2002, explaining that you received a letter from the Florida Department of State questioning a business Seng Tire, Inc. was conducting in Florida in January, 1998.

The copy of your letter, dated January 31, 2002, directed to Theresa with the Florida Department of Revenue, states that Seng Tire, Inc. opened a business in Florida in April 2000, with your first sale being in May, 2000. It explains that if a Florida sale was made prior to that date, it was an interstate sale.

A review of the Department of Revenue's records indicates that Seng Tire, Inc. registered to collect sales tax on January 22, 2001, and was obligated for sales tax and Florida Corporate Income Tax on and after January 1, 2001.

Based on our telephone conversation and a review of the Department's records, Seng Tires, Inc. sells tires at wholesale, and is therefore, not obligated to collect sales tax. The sales tax and solid waste fees on tires are collected on retail sales.

We have requested a reprint of your DR-11 and DR-13 reflecting a change of address from West Palm Beach to South Bay, Florida.

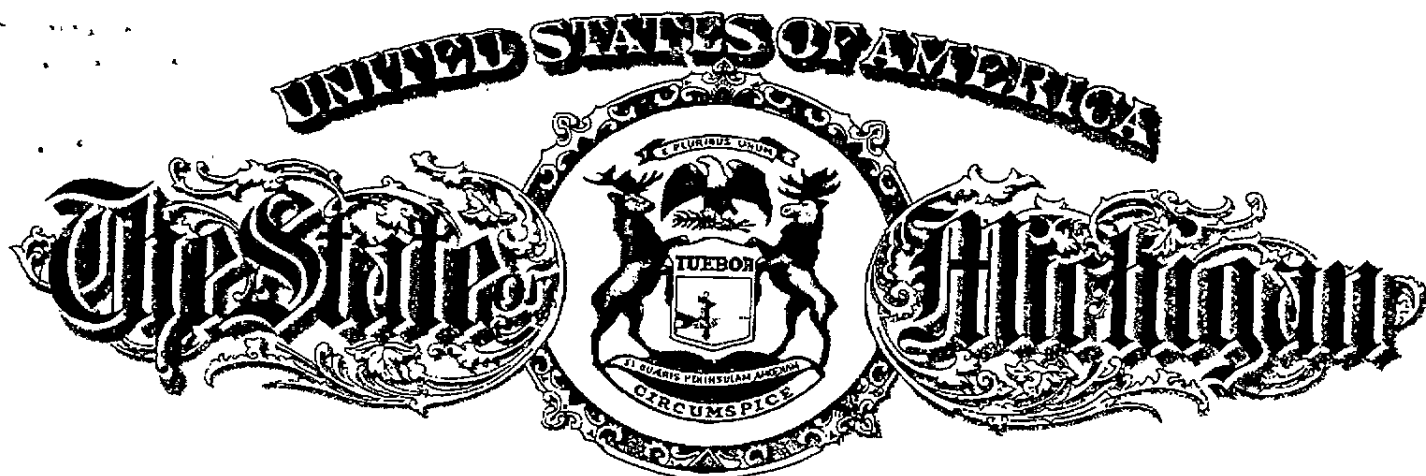
