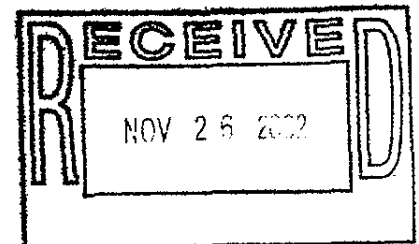

Bartlett Services, Inc. (Bartlett) employed the services of Mr. Williams C. Peoples back in mid 1998 as a salesperson for our Remote Monitoring System (RMS). Mr. Peoples spends a large amount of his time traveling both in and out of the United States selling our RMS equipment (see attached marketing brochure). While not on travel status, Mr. Peoples does conduct business calls, faxes and e-mail from his home in the State of Florida. We have always reported his wages for unemployment purposes, and remitted the related taxes, to the State of Florida.

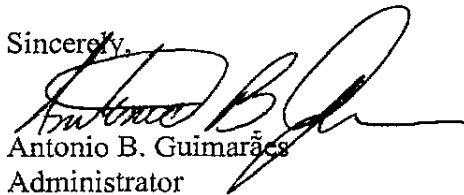

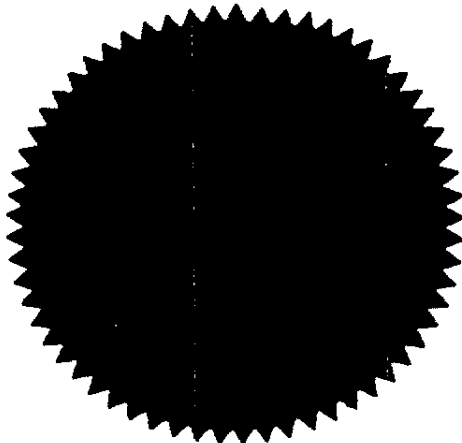
