This reply is in response to your letter dated September 19, 2002 (copy enclosed) for the above referenced corporation. While we understand the statute, we would like to present the following mitigating information.

In September, 1999, the controller for the above referenced corporation began to pay payroll to one of its employees which had moved to Florida. At that time, the controller registered for Florida employer payroll taxes. At the time, the controller believed that he had taken all the steps necessary to comply with registering to do business in Florida. Subsequently, when it was believed that Florida sales tax were going to be collected, the controller registered with Florida for collection of such tax. Again, the controller believed that he was in compliance with the registration requirements of Florida.

When it came time to file Florida corporate tax returns, it was determined that the corporation did not have a Florida document number. In speaking with the Florida Department of Revenue, the controller discovered that he needed to complete a document for the Registration Section of the Florida Division of Corporations in order to be assigned a Florida document number. The controller completed this form and submitted such together with the appropriate fee and required certificate from Massachusetts. It was the submission of this document that led to the imposition of the civil penalty.

As you can see by the above information, there was no intention by the Company to avoid registration with Florida. The controller believed he had properly registered with the appropriate departments/divisions. We, therefore, respectfully request that the civil penalties of \$1,000 per year for three years, or \$3,000, be abated. The additional fee of \$150 per year for three years of Uniform Business Reports is agreed with, and we have, accordingly, attached a check for \$450 and a Uniform Business Report to bring the Company to current status. There have been no changes in officers or directors since the start of doing business in Florida.




