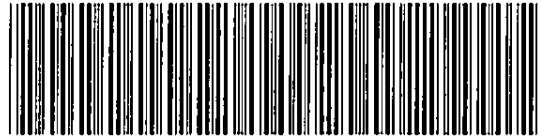

THIRD: The effective date of dissolution of the Company is the date of filing of the Articles of Dissolution.


FOURTH: The Company is hereby dissolved by the written agreement of its sole Shareholder pursuant to Section 607.1403, Florida Statutes.
