I am writing in response to your letter dated June 6, 2002 (Letter Number 902A00037359). Enclosed are the following documents:

- 1) An Original Certificate of Good Standing from the Kentucky Secretary of State;
- 2) Certificate of Liability Insurance
- 3) IRS FORM 940 for years 1994 through 2001

As you can see from my earlier correspondence, our firm represents Harry Rust Construction Company, Inc., a Kentucky corporation (herein "Harry Rust Construction"). Harry Rust Construction has had business activity in the State of Florida since approximately 1992.

As you can see from the enclosed documentation, Harry Rust Construction has properly remitted all unemployment taxes to Florida and has maintained worker's compensation coverage for its workers in Florida. In fact, it seems the only thing that Harry Rust Construction failed to do was properly register with the Secretary of State's office. Therefore, I am requesting that the penalty referenced in your June 6, 2002 letter be waived in light of Harry Rust Construction's substantial compliance with all other Florida laws. In the alternative, Harry Rust Construction requests that the penalties in this case be reduced to the minimum penalties permitted by law.

While Harry Rust Construction appreciates the importance of registering with the Secretary of State's office, Harry Rust Construction submits that the substantial penalty (over \$11,000) is unwarranted in this case because Harry Rust Construction has made sure that Florida received the unemployment taxes it was entitled to receive and made sure that its Florida workers were covered by worker's compensation insurance.
