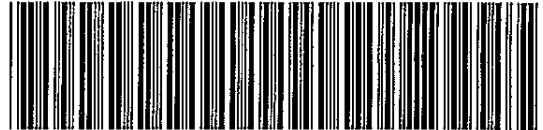

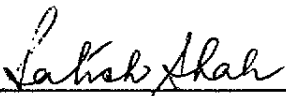

In response to your letter number: 003100001381, a call was made by our representative in Florida to your document specialist. This call was to gain an understanding of the reason for the penalties referred to in the referenced letter. SkyBridge Global is an Atlanta based company that has provided independent contractors in Florida for IT consulting services. All work has been contracted through the Atlanta office.

Your document specialist referred us to Florida Statute 607.1501. Under this statute item (2) describes activities that do not constitute transacting business within the meaning of subsection (1). Item (f) refers to soliciting or obtaining orders, whether by mail or through employees, agents, or otherwise, if the orders require acceptance outside Florida before they become contracts.

Based on this exemption, it was inaccurate for our registration request to include International Speedway business that was started on 10/21/2001. This contract and all SkyBridge Global contracts require approval by representatives in Atlanta. Based on our understanding of this statute, we request that you withdraw the penalty and continue to process our request.
