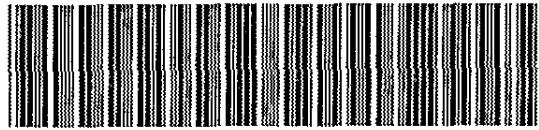

Dear Mr. Kohr:

As I discussed with you today on the telephone, I am respectfully requesting that the Florida Department of State waive the penalty fees and annual report/uniform business report fees against my client, the above-referenced Idaho corporation which is doing business in your state.

As I indicated to you, the failure to qualify the corporation to transact business in the State of Florida and file the annual report/uniform business report since 2001, the year the company started conducting business in your state, was due to an inadvertent misunderstanding on my part with regard to the proper form to file in order to qualify the corporation in Florida. My office mistakenly prepared and filed with your office, with the appropriate fees, an Application for the Registration of a Foreign Corporate Name in 2001 and a Renewal Application for a Foreign Name Registration for Foreign Profit Corporation for the 2002 calendar year. Copies of those filings are faxed herewith.

When preparing the renewal for 2003, I double checked whether the form we were filing was the correct one and learned that we should have filed the Application for Authorization to Transact Business in Florida. I immediately prepared the correct application and filed it with your office and, being honest, reported that the corporation had begun transacting business in Florida in 2001. Needless to say, your letter to me dated January 28, 2003, regarding the penalty fees and report fees has caused me great concern.


