- 1. I am an individual over eighteen (18) years of age, and am the General Counsel for Topiclear, Inc., a Delaware corporation ("Corporation").
- 2. I prepared the Application by Foreign Corporation for Authorization to Transact Business in Florida ("Application"), and inadvertently, mistakenly and unknowingly provided erroneous information on the Application pertaining to the date the Corporation first transacted business in Florida, as that phrase is defined under §607.1501(2), Florida Statutes.
