Based on my review of the file and the information received from the corporation, it is my recommendation that this file be closed. Corporation erroneously represented on its December 23, 2002 application it had "conducted its affairs" in Florida since 1962, notwithstanding the fact its activities do not come within the definition of a "conducting affairs" under section 617.1501, Florida Statutes. I am writing regarding the letter we recently received from you, a copy of which is enclosed. I was very surprised to see we owe the state of Florida \$11,673.75 in registration and penalty fees. I would like to know if it is possible to appeal the amount of penalty fees that were assessed.

January 6, 2003

SEND is committed to complying with applicable state laws and we pay any registration fees that are required. However, when you are dealing with fifty states we do depend on notification from the state for renewal notices. I cannot say with certainty what happened twenty years ago but I would assume we did not receive your renewal notice. If you will look at your records, I believe you will find that we had paid the fee regularly until that time. In addition, when we recently received notice that the fee needed to be paid we promptly replied.

I do understand that not receiving the notification does not absolve us from the responsibility to pay the fee but would ask for consideration in assessing penalties. We would be willing to pay the fees owing for the past 20 years, as we would have paid them anyway if we had received notification. It just seems that the penalty amount is excessive in this situation.

SEND International is a non-profit organization and approximately \$10,000 in penalties would be a hardship for us. We do wish to continue to do business in Florida and would ask for your consideration in reducing the penalty. Thank you very much for your assistance.


