

**ARTICLES OF AMENDMENT
OF
SUNQUEST INFORMATION SYSTEMS, INC.**

Pursuant to Section 1915 of the Pennsylvania Business Corporation Law of 1988, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending the corporation's Amended and Restated Articles of Incorporation:

1. The name of the corporation (hereinafter called the "Corporation") is Sunquest Information Systems, Inc.
2. The address of the registered office and county of venue of the Corporation is Corporation Service Company in Dauphin County.
3. The Corporation was incorporated in Pennsylvania on April 13, 1981.


"1. The name of the corporation is: CliniSys, Inc."
