This will acknowledge receipt of your letter dated February 28, 2003, concerning the authorization of the above referenced entity to transact business in Florida. A review of our files has revealed the following:

Your original application was received by our office on July 2, 2001. Said application did not meet our filing requirements and was returned to you for corrections on July 10, 2001. According to our file we never received a response to this letter.

Our subsequent review of the file revealed the following corrections are still needed before we can authorize your corporation to transact business in Florida:
