We are in receipt of your letters dated March 21, 2002 and January 7, 2003 (copies enclosed) regarding our application to transact business in Florida. The letters state that we are being denied the privilege to transact business in the state of Florida since we have not obtained a certificate of authority to do so.

We are in agreement with the assessment in terms of the annual report fees of \$600.00.

However, with regard to the penalties assessed in the amount of \$4,000.00, we respectfully request the penalties be abated for reasonable cause. Kindly understand that we were not informed by our outside accounting firm, who has been filing our tax return in the state of Florida, that we had to obtain a certificate of authority to transact business in the state, thus should be filing annual reports.

The foregoing facts support that Shiseido International Corp.'s failure to file for the certificate of authority was not due to intentional disregard of the corporation's filing responsibilities or willful neglect, but due to administrative oversight. Accordingly, we request that the penalties be abated and a revised assessment be computed to remove such penalties.

Kindly accept our check in the amount of \$600 for the annual report fees.

Moreover, Shiseido International Corp. has been experiencing a vast amount of turnover in the past year. I am new to this organization also. Therefore, please accept our apologies for the late response to the letters and any inconveniences this may have caused. We are working on developing better processes.
