On behalf of Bank of Alabama, an Alabama banking corporation which is currently authorized to transact business in Florida as a foreign corporation (the "Corporation"), I am enclosing herewith: (i) an application for amendment to application for authorization to transact business in Florida, which is filed to reflect the change of the name of the Corporation to "CapitalSouth Bank"; (ii) a copy of the Certificate of Amendment reflecting this name change, certified by the Alabama Secretary of State; and (iii) a check in the amount of \$48.75 for the filing fee and fee for one certified copy of the amendment to application for authorization to transact business in Florida.

Prior to the Corporation's formally amending its name, we requested and received approval from the Florida Office of Financial Regulation (the "OFR") for use of the name "CapitalSouth Bank, a division of Bank of Alabama" by the Corporation as a fictitious name in the State of Florida. Please see the enclosed letter from Director Linda Charity of the OFR indicating her office's non-objection to the use of such name as a registered foreign entity name or a fictitious name in the State of Florida. Because the Corporation has now formally amended its name, the phrase "division of Bank of Alabama" is no longer accurate or necessary as a part of the name. The Corporation is a "financial institution" within the meaning of Florida Statutes Section 655.005(h) and is already authorized to do business in the State of Florida. Therefore, as noted in Ms. Charity's letter, Florida Statutes Section 655.922 does not restrict its use of the new name.

Please send the certified copy of the amendment to application for authorization to transact business in Florida to my attention.



FOURTH ARTICLES OF AMENDMENT TO THE CERTIFICATE OF INCORPORATION OF BANK OF ALABAMA



TO THE HONORABLE JUDGE OF PROBATE, JEFFERSON COUNTY, ALABAMA:

Pursuant to the provisions of Sections 5-5A-17, 10-2B-10.03 and 10-2B-10.06 of the Code of Alabama (1975), as amended, Bank of Alabama, an Alabama banking corporation (the "Corporation"), adopts and delivers for filing the following Fourth Articles of Amendment to the Certificate of Incorporation of the Corporation:

- 1. The name of the Corporation is Bank of Alabama.
- 2. Article I of the Certificate of Incorporation of the Corporation shall be amended to read as follows:

"The name of the corporation shall be CapitalSouth Bank".

- 3. This amendment was adopted as of September 9, 2005.
- 4. The number of shares of the common stock of the Corporation outstanding at the time of the adoption of this amendment was 226,450 shares, and the number of shares of common stock entitled to vote thereon was 226,450 shares. The number of shares of the preferred Class A stock of the Corporation outstanding at the time of the adoption of this amendment was 1,500 shares, and the number of shares of preferred Class A stock entitled to vote thereon was 1,500 shares.
- 5. The sole shareholder of the Corporation approved the amendment by an action by written consent in lieu of a meeting. The number of shares of common stock voted for said amendment was 226,450, and no shares of common stock were voted against said amendment. The number of shares of preferred Class A stock voted for said amendment was 1,500, and no shares of preferred Class A stock were voted against said amendment.
- 6. The effective date and time of these Fourth Articles of Amendment to the Certificate of Incorporation of the Corporation shall be September 30, 2005 at 5:00 p.m. Central Daylight Time.
