Dear Ms. Harvey:

This letter is in response to the letter of March 12, 2003 from Buck Kohr, Corporate Specialist regarding penalty fees owed by Puckorius & Associates, Inc. In a conversation with Mr. Kohr, he suggested that my response be made to you.

When I opened my Florida office in September, 2000 calls were made to the Division of Corporations asking if a Virginia Corporation that had two locations in Virginia and now one in Florida had to register in Florida or needed to change their Corporation documents through the State. The response then, as we also heard subsequently, was that we needed to contact Virginia to see if this was required. An application to conduct business in Florida was not referred to in this conversation. Since that time the Virginia k cations have been closed and only the one Florida office exists for Puckorius & Associates, Inc.

Earlier this year I requested my assistant to check again with the Florida Division of Corporations to make sure that there wasn't some type of form you required since we were totally in Florida. From this call we were directed to the web site and obtained the Application By Foreign Corporation for Authorization to Transact Business in Florida which we sent to your offices with the \$78.75.

From the 2002 Florida Statutes, 607.1501, web site information there are two leasons I did not think we were required to do more than what we did this March. Sections 607.1501 (2) (e) (Selling through independent contractors) and (i) (Transacting business in interstate commerce), I felt gave my firm the reason(s) for not having to obtain a certificate of authority for I work through a broker/dealer, InterSecurities, Inc. of Clearwater, Fl. who had registered my firm as a branch office, see copy of Department of Banking and Finance license. Also, since my business is working with clients throughout the country I felt this would be conducting business in interstate commerce.

You will also see that I have an occupational license from Avon Park as well as Highlands County having notified them of my existence and receiving appropriate paperwork to file for these licenses. Mr. Kohr wondered how I was able to obtain these licenses without having registered my firm in the State. There was never a question on if I was registered and if there had been, obviously it would have led me to filing the Application By Foreign Corporation For Authorization to Transact Business it Florida

In addition, my accountant filed a Florida tax return in 2000 and was told that since I am an S Corporation there would be no need to file subsequent returns. This filed return, I would have imagined, should have triggered some type of paperwork from the Division of Corporations or related division since this showed I was a new company in the State.

We received, postmarked March 11, 2003 – see attached, a reproduced copy titled "Important Notice" stating that as a Corporation operating in the State of Florida I am required to register with the Florida Department of State, Division of Corporations. This is the first letter ever received on this matter from the State of Florida and probably was prompted by our mailing of March 4, 2003.

There is no way I would have avoided doing the right and proper filing and I did try to obtain information on how I should proceed. My business is dealing with clients' financial affairs and obtaining the trust needed to work closely with them. This same integrity applies to my entire business dealings and I strongly feel that the penalty imposed of \$3,450 is unfair and unjust.

Needless to say, I have been distraught over this penalty and would like you and your colleagues to please reconsider the penalty for a number of reasons expressed above.






