We are in receipt of your letter dated April 1, 2003 informing us that Pattillo Property Management, Inc.'s ("PPMI") Application by Foreign Corporation for Authorization to Transact Business in Florida (the "Application") was not recorded due to the lack of signature by an officer. In addition, you indicated that a penalty of \$1,150 would be assessed due to PPMI failing to qualify to operate in Florida.

Upon review of the Florida Statutes that you enclosed with the aforementioned letter, we have determined that, based on section 607.1501, subsection 2, item (J), PPMI did not transact business within the State of Florida during 2002, nor has PPMI engaged in business transactions within Florida as of the date of this letter. PPMI still wishes to seek application for authorization to transact business within Florida for future operations.

Section 607.1501, subsection 2, item (J) states "the following activities, among others, do not constitute transacting business within the meaning of subsection 1.......(j) conducting an isolated transaction that is completed within 30 days and that is not one in the course of repeated transactions of a like nature". Item 6. on the Application erroneously indicated that the date the entity first transacted business was on September 5, 2002. Upon our review of that activity, it is clear that the activity falls under the type described in item (J) quoted above.

As such, and based on the fact that PPMI has not transacted business in Florida since that date, I am returning the Application signed by an officer and with Item 6 of the Application changed to indicate that the first day of business transacted is "upon qualification".

I thank you in advance for your assistance in this matter.
