



### CERTIFICATE OF AMENDMENT OF THE CHARTER

OF

#### SUMITOMO MARINE & FIRE INSURANCE COMPANY OF AMERICA

Under Section 1206 of the
Insurance Law of the State of New York
And Section 805 of
the Business Corporation Law of the State of New York

Pursuant to the provisions of Section 1206 of the Insurance Law of the State of New York and Section 805 of the Business Corporation Law of the State of New York, the undersigned, being the President and Secretary of Sumitomo Marine & Fire Insurance Company of America (the "Corporation") hereby certify:

FIRST:

The name of the Corporation is Sumitomo Marine & Fire Insurance

Company of America.

SECOND:

The Charter of the Corporation was filed with the New York State

Superintendent of Insurance on March 29, 2001 and has not been

subsequently amended.

THIRD:

Article I of the Charter, which sets forth the name of the Corporation, is

amended to read as follows, effective July 1, 2003;

Article I. Corporate Name: The name of the Corporation shall be Mitsui

Sumitomo Insurance Company of America.

FOURTH:

Article II of the Charter, which sets forth the place of business of the

Corporation, is amended to add the following:

The Corporation shall have the power to establish other offices in this State and elsewhere in the United States and in any part of the world and

to conduct its business wherever authorized by law.

FIFTH:

Article VI (C) of the Charter is amended to read as follows, in order to

allow new directorships and vacancies occurring in the Board to be filled

by majority vote of the Board, as well as by vote of the shareholders:

Newly created directorships resulting from an increase in the number of

directors and vacancies occurring in the Board shall be filled by vote of

the shareholders or by majority vote of the Board.

SIXTH:

This amendment of the Charter was authorized by written consent of the

holder of all outstanding shares of the Corporation dated June 23, 2003, which followed written approval by Unanimous Consent of the Board of

Directors of the Corporation dated June 23, 2003.
