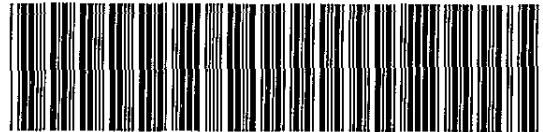

This letter responds to your letter dated 3/10/03. A copy is enclosed with this letter.

In your letter you state that Blaine Larsen Farms, Inc. (BLF) owes the State of Florida \$6,900 for civil penalties. You state this amount is owed because BLF was not registered to do business in the State of Florida since 1997. This is incorrect.

Larsen Farms Hay Terminal, Inc. (LFHT) an entity related to BLF, has been doing business in Florida since December 18, 1997. It has registered each year (1997-2002) with the State of Florida to do business as a foreign entity.

In 2002, LFHT merged into BLF. At the beginning of 2003, we sent your office an Application For Withdrawal for LFHT. We sent an Application For Authorization To Do Business on behalf of BLF. There has always been an entity registered to do business since 1997. The only change has been that LFHT merged into BLF.

Our understanding is that the Application For Withdrawal for LFHT has been filed. We are only waiting for the Application To Do Business to be filed on behalf of BLF. Please file the application on behalf of BLF.


