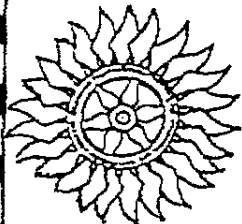

(Pursuant to Article 10 of the Religious Corporations Law)

We, the undersigned, all being persons of full age of whom at least two-thirds (2/3) are citizens of the United States, and at least one (1) resident of the State of New York, for the purposes of incorporating an unincorporated congregation known as IGLESIA CRISTIANA PENTECOSTAL MOVIMENTO LAS MARAVILLAS DEL EXODO, INC., pursuant to Article 10 of the Religious Corporations Law, hereby certify as follows:

FIRST: A meeting of IGLESIA CRISTIANA PENTECOSTAL MOVIMENTO LAS MARAVILLAS DEL EXODO, INC., an unincorporated congregation or church, was duly called and held in conformity with the aforesaid article of the Religious Corporations Law, at 2875 Atlantic Avenue, Borough of Brooklyn, County of Kings, City and State of New York, on the 30th day of June, 1984, at which meeting a majority of the duly qualified voters of said corporation, being at least five (5) in number were present.

SECOND: At said meeting REV. DAVID MALDONADO, one of the subscribers hereto, was presiding officer, and BASILIDES CARRION, JULIO SANTIAGO, MARITZA CARRION and



EDWARD O'FARIEL, the other subscribers hereto, were present and voted thereat.

THIRD: At said meeting it was duly decided that such unincorporated congregation should become incorporated.

FOURTH: The name of the proposed corporation as decided at said meeting is to be IGLESIA CRISTIANA PENTECOSTAL MOVIMIENTO LAS MARAVILLAS DEL EXODO, INC.

FIFTH: That the purposes of said corporation are:

a. To establish and maintain a congregation or church for the purpose and intent of promoting religious worship according to the tenents, precepts and beliefs of Christian worship and to conduct religious services, as indicated by the Board of Trustees of the said church or congregation.

b. To teach and preach the Gospel of the Grace of God in its fullness and to disseminate the belief in a deeper and higher Christian life.

c. To further the work of Evangelization in the Light of the Precepts of the Congregation and Church, particularly among the poor and neglected classes.

d. To promulgate and preach the faith as enunciated heretofore or any other practical methods of spreading the Glory of God and the preaching of the Gospel in its fullest.

e. To maintain and sponsor religious schools or places of study for the study of the Bible and non-academic subjects and to further Christian education in all fields.

SIXTH: That the said corporation shall have the power to purchase, lease or otherwise acquire, and to sell, mortgage or lease real property, whether improved or unimproved, or any interest thereof, to acquire associate houses, church buildings, school houses for schools and property for the residence of its ministers, teachers and employees.

SEVENTH: The foregoing clauses shall be considered both as objects and purposes, and it is hereby expressly provided that the foregoing enumeration of specific objects and purposes shall not be held to limit and restrict, in any manner, the powers of the corporation, but shall be entitled to have powers pursuant to the laws of the State of New York.

EIGHTH: The number of trustees shall be THREE (3) as follows: REV. DAVID MALDONADO, BASILIDES CARRION, JULIO SANTIAGO, , to hold office until the first annual election, thereafter, then new trustees shall be elected.

NINTH: The principal place of worship of the said corporation shall be located at 2875 Atlantic Avenue, Borough of Brooklyn, County of Kings, City and State of New York.

TENTH: That the annual meeting for the election of officers for the corporation shall be held on the first Monday of June of each year.

ELEVENTH: Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such manner, or to such organization or organizations organized and operated exclusively for charitable, missionary work, religious, educational, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any of such assets not so disposed of shall be disposed of by the Supreme Court of the State of New York of the County in which the principal office of the corporation is then located, exclusively for such purpose or to such organization, or organizations as the said court shall determine which are organized and operated exclusively for such purposes.
