#### Gentlemen:

My client, Vacuum Solutions Group Southeast Corporation, has received the attached letter. Therein, you state that they are liable for a penalty for each year they have transacted business in Florida prior to qualification. The law does not state that you must file within the calendar year in which you start doing business. It does not say you must file within Florida's fiscal year, which if like most other municipalities ends on June 30. It cannot be that if you start business December 15 you have 15 days to file and if you start January 15 you have 350 days.

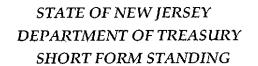

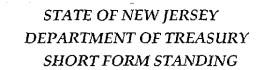
