



We are writing to request that the Application by a Foreign Corporation for Authorization to Transact Business in Florida (the "Application") for Tonito Corp., a Panama corporation (the "Corporation") be amended with respect to the date on which the Corporation first transacted business in Florida. As prepared, the Application reflects that the Corporation first transacted business in Florida on March 1, 2002. However, this date refers to the date on which the Corporation purchased interests in a Florida limited liability company, and not the date on which the Corporation first transacted business in Florida.

Under Florida Statutes Section 607.1501(2), a foreign corporation is not considered to be transacting business in the State of Florida if its activities solely consist of, among others: (i) owning and controlling a subsidiary corporation incorporated or transacting business within Florida, or owning the stock of any corporation which it has lawfully acquired; or (ii) owning a limited partnership interest in a limited partnership that is doing business within the State of Florida, unless such limited partner manages or controls the partnership, or exercises the powers and duties of a general partner.

In this case, the Corporation owns a minority membership interest in a limited liability company organized in Florida. The Corporation is not a manager of the limited liability company, and does not exercise control over the daily operations of the limited liability company. Therefore, the ownership by the Corporation of such membership interest, by itself, should not constitute the transaction of business in Florida.
