Re: Application for Authority to Indirectly Acquire a Controlling Interest in Admiralty Bank, Palm Beach Gardens, Palm Beach County, Florida, by Royal Bank of Canada, Montreal, Quebec, Canada, and RBC Centura Banks, Inc., Rocky Mount, North Carolina (Applicants) (Administrative File No. 4164-B-12/02)

The Comptroller of the State of Florida, as head of the Department of Banking and Finance (Department), having considered the information presented in the application for authority to indirectly acquire a controlling interest in Admiralty Bank by Royal Bank of Canada and RBC Centura Banks, Inc., (Applicants), gives notice that the Department intends to approve the application and makes the following:

FINDINGS OF FACT

- An application for authority to indirectly acquire a controlling interest in Admiralty Bank was filed with the Department on October 7, 2002.
- (2) The application was deemed substantially complete on October 19, 2002, and has a decision due date of January 19, 2003.
- (3) Notice of the application was published in the Florida Administrative Weekly on October 18, 2002. No hearing was requested and none was held.
- (4) The Board of Governors of the Federal Reserve System received an application from Royal Bank of Canada and RBC Centura Banks, Inc., to acquire Admiralty Bancorp, Inc., and thereby indirectly acquire its subsidiary, Admiralty Bank.
- (5) RBC Centura Banks, Inc., is a North Carolina organized financial holding company registered under the Bank Holding Company Act and it is headquartered in Rocky Mount, North Carolina.
- (6) Royal Bank of Canada is a Canadian chartered bank and financial holding company and it based in Montreal, Quebec, Canada. RBC Centura Banks, Inc., is a wholly owned subsidiary of Royal Bank of Canada.
- (7) Admiralty Bancorp, Inc., is a Delaware organized financial holding company registered under the Bank Holding Company Act, headquartered at 4400 PGA Boulevard, Polm Beach Cardens, Palm Beach County, Florida. Admiralty Bank is a wholly owned subsidiary of Admiralty Bancorp, Inc.

- (8) The Bank is a state-chartered bank with its main office located at 4400 PGA Boulevard, Palm Beach Gardens, Palm Beach County, Florida. It is authorized to operate 3 branch offices in Palm Beach County, 2 branch offices in Orange County, 3 branch offices in Brevard County, one branch office in Broward County, and one branch office in Seminole County. The Bank commenced operation on May 28, 1987.
- (9) The indirect acquisition of the Bank will be accomplished through the acquisition of Admiralty Bancorp, Inc., by the Applicant.
- (10) All of the issued and outstanding shares of the Bank will be acquired by the Applicants upon consummation of the acquisition of Admiralty Bancorp, Inc., by the Applicants.
- (11) Upon consummation of the transaction, the application states that Shauncen E. Bruder, Scott M. Custer, Howard K. Landis, III, Frank L. Pattillo, and Cecil W. Sewell, Jr., will be added as directors of Admiralty Bank. The resulting board of directors will meet the requirements of Section 658.33, Florida Statutes.
- (12) The Office of Financial Investigations conducted a background investigation of Shauneen E. Bruder, Scott M. Custer, Howard K. Landis, III, Frank L. Pattillo, and Cecil W. Sewell, Jr. No derogatory information was found.
- (13) The application indicates that no changes will be made with the current executive officers of the Bank.
- (14) RBC Centura Bankt, Inc., is a wholly owned subsidiary of Royal Bank of Canada and there are no individual shareholders that own and/or control 10 percent or more of the outstanding stock of Royal Bank of Canada.

Having considered the application, the Department concludes that the application satisfies the criteria of Section 658.28, Florida Statutes. Consequently the Department intends to approve this application subject to the following conditions:

- (1) That the Board of Governors of the Federal Reserva System or its designee approves the application from Royal Bank of Canada and RBC Centura Banks, Inc., to acquire Admiralty Bancorp. Inc., and thereby indirectly acquire its subsidiary, Admiralty Bank.
- (2) That the Bank shall notify the Department of the proposed appointment of any individual to the board of directors or the employment of any individual as an executive officer or equivalent position at least 60 days before such appointment or employment becomes effective. This requirement shall be in effect for the two years following consummation of the acquisition.
- (3) That upon consummation of the transaction, the current executive officers will continue to serve in those expacities. The following individuals will be added to the board of directors of the Bank: Shauneen E. Bruder, Scott M. Custer, Howard K. Landis, III, Frank L. Pattillo, and Cecil W. Sewell, Jr. Upon consummation of the indirect acquisition, the following current directors: William Berger, David Dickenson, Leslie E. Goodman, Thomas L. Gray, Thomas J. Hanford, Sidney Hofing, Douglas Hooker, Patrick Mathes, Peter L. A. Pantages, Richard Rosa, Craig Spencer, Joseph Veccia, Mark Wolters, III, and George Zoffinger will no langer serve in that capacity with the Bank.

- (4) That upon consummation of the transaction, the current executive officers will continue to serve in that capacity.
- (5) That the Department be provided with copies of any agreements or contracts between the Bank and Royal Bank of Canada or the Applicant, their wholly-owned subsidiary banks, or any company, partnership, or other business entity owned or controlled by any of the directors, officers, or affiliated parties, prior to execution of any such agreement or the transaction of any business between the signatory parties under the terms of such agreement. This condition shall be in effect for the first two years following the acquisition of the Bank.
- (6) That the consummation of the acquisition of control conforms to all requirements of State and Federal Law.
- (7) That any substantial change in the structure of ownership from that proposed in the application must be reported to the Department to determine continued compliance with Section 658.28, Florida Statutes.
- (8) That written notice is provided to the Division of Banking at the time transfer of the shares is accomplished.

The Department will issue a conditional Final Order of Approval after the expiration of the 21 day period contained in the Notice of Rights unless the Applicant has elected to waive its right to a hearing by providing written notification of such waiver to the Department. Before all the conditions specified above and other reasonable requirements of the Department have been fulfilled, or if any interim development is deemed by the Comptroller to warrant such action, the Comptroller retains the right to alter, suspend, or withdraw approval of the acquisition of the Bank. This approval shall expire six (6) months from the date of the Comptroller's Final Order, unless in the meantime a request for an extension of time has been granted by the Department.

In taking this action, the Department has relied on the representations and commitments made by Applicants in the applications and all supplemental information submitted. Every effort should be made to meet these representations and commitments. Please keep the Division of Banking advised of the steps being taken to comply with the conditions imposed in this Notice.
