Further to your letter of April 17th, 2003 and our subsequent telephone conversation, I would respectfully request your consideration of the following facts relative to penalties being imposed for conducting business in Florida prior to qualification.

As you know, C.M. Security Group Inc. has been supplying security windows to the State of Florida including the Department of Corrections since 1995. Until we attended a recent administrative hearing in Tallahassee, we were unaware that we were required to be registered to do business in the State of Florida. Up till now, no one has ever requested this qualification and during the hearing, the Department of Corrections admitted that they had been negligent in not doing so.

We have acted in good faith in successfully bidding and supplying quality stainless steel detention windows for many of the State's window replacement projects and would certainly have applied for qualification and paid the necessary annual fees had we been aware of the requirement or requested to provide same.

It would be appreciated if you would review this case and consider imposing the minimum penalty of \$500.00 for each year instead of the maximum \$1000.00 penalty. We look forward to receiving a revised claim so we can forward payment.

Based upon the information provided by this corporation, it is my recommendation that this file be closed. According to Judith Dorais, Contract Administrator for the corporation, the corporation applied for authority to conduct its affairs in Florida on April 16, 2003 and erroneously represented it has transacted business in Florida since October 26, 1995. According to both Dorais and Gerald Spenard, Vice President of the Corporation (Spenard's affidavit is attached), the corporation's only activity consisted of shipping (from Montreal, Quebec) finished goods to Florida. It seems unlikely the corporation has conducted its affairs in Florida as defined in Section 607.1501, Florida Statutes. It is my opinion that outstanding fees and penalties are not actually owed. 
