





CERTIFICATE OF INCORPORATION

OF

ARK OF CHRIST MISSION INTERNATIONAL, Inc.
PURSUANT TO ARTICLE 10 OF THE RELIGIOUS CORPORATION LAW

We, the undersigned, all being persons eighteen years or older for the purpose of incorporating an unincorporated non-denomination church, pursuant to Article 10 of the Religious Corporations Law, hereby certify as follows:

FIRST: A meeting of ARK OF CHRIST MISSION INTERNATIONAL CHURCH, an unincorporated non-denomination church was called and held in conformity with the Article 10 of the Religious Corporations Law at 308 Linden Blvd., Brooklyn, N.Y. 11226 on January 26, 1980, at which meeting a majority of the qualified voters of the church, being at least six in number were present.

SECOND: At said meeting, Robert E. Cann one of the subscribers, presiding officers, Ansella Payton and Deanna B. Armstrong; the other subscribers, were present and voted.

THIRD: At said meeting it was duly decided that the church should become incorporated.

FOURTH: The name of the proposed corporation, decided upon at the meeting is to be ARK OF CHRIST MISSION INTERNATIONAL, INC.

FIFTH: The number of trustees shall be ~~5~~ (three)

SIXTH: The first annual election of the trustees shall be held on January 26, 1981, and the annual election of trustees shall each year thereafter be held on the twenty-six day of January.

SEVENTH: The names of the persons elected as trustees are as follows: Robert E. Cann, Ansella Payton, Deanna B. Armstrong, Ida A. Rose and Maude Quashia to hold office until the first annual election of trustees.

EIGHTH: The principal place of worship of the church is located in Brooklyn, New York, at 308 Linden Blvd.

NINTH: The purpose for which the said corporation is to be formed are as follows:


- To establish and maintain a place for the worship of the almighty God.

- To meet the total needs for the total man including the spiritual, intellectual, emotional, social and physical.
- To rent, lease or purchase such building or edifices which might be needed by the congregation, to alter or repair same, and to dispose of same when no longer needed or used by the corporation.
- To buy vacant land(s) or building(s), alter, develop, build or repair same for the use of the corporation, and to dispose of same when no longer needed.
- To hold and operate such property which shall come into possession of said corporation and sell, assign, transform otherwise dispose of any and all of the securities, properties and rights which may anytime be acquired or held by this corporation and in all respects to deal with and in the same insofar as may lawfully be done under the provisions of the Religious Corporation Law. To borrow money and contract debts when necessary for the exercise of its corporation rights, privileges, or for any other lawful purpose of its incorporation, and it may issue and dispose of its obligation for any amount borrowed, to issue bonds, securities or obligations from time to time and for and of the objects or purposes of this corporation, and to mortgage its property, and/or to make said deed of trust as may be necessary to secure the payment of such obligation or of any debts contracts for such purposes.
- To enter into, make perform and carry out contracts with any person, firm or corporation.

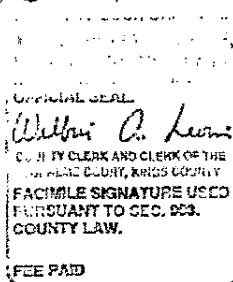


