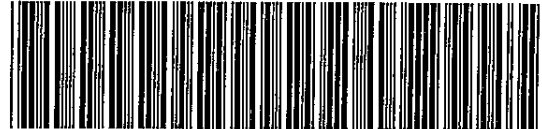


I am in receipt of the subject letter claiming I owe a penalty to your office. Last year I registered as a foreign corporation and received the Document Number E02000000024. It was my understanding that in order to conduct business in Florida as a Travel Agency I was only required to Register with the Department of Agriculture as a Seller of Travel. I was not aware of any additional requirements other than to obtain a County occupational license. When I inquired about reregistration as a foreign corporation this year, I was informed that I had to file a different form to conduct business as a foreign corporation in Florida. I assure you I did not intentionally fail to file the proper form last year. The form filed was on the advice of my legal advisor, Haag, Friedrich and Wilcox, P.A. My late filing to renew registration for this year was an oversight.

My agency is small, consisting of only myself and my husband, and is operated out of our home. Most of our business is still conducted with clients in Maryland where we previously resided. I hope you will reconsider penalizing me for an unintentional failure to file the proper forms in a timely manner.

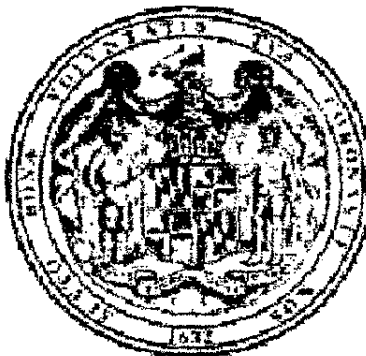
