I am writing on behalf of our client, Neighborhood Stabilization Fund, Inc. (NSF), in response to your office's January 9, 2003 letter, which indicated that NSF's Application by Foreign Corporation/Limited Liability Company for Authorization to Transact Business could not be processed due to NSF's failure to obtain a certificate of authority prior to conducting affairs in Florida. This letter also stated that NSF is liable for \$7,428.75 in fees and penalties for failing to procure such authorization. At the suggestion of Buck Kohr from the Division of Corporations, I wrote you a letter, dated March 14, 2003, alerting you of this situation. As a follow-up and with the hope of amicably resolving this matter, I am writing to explain our client's position.

NSF is a non-profit corporation that provides financial assistance to low-income homeowners who encounter difficulties with their mortgage payments. NSF is a domestic corporation of Massachusetts and is in good standing with the Secretary of the Commonwealth of Massachusetts. As stated in NSF's application, it began helping Florida homeowners facing foreclosure on or about June 13, 1995. At that time, our client believed in good faith that its activities in Florida did not constitute "conducting affairs" for the purpose of 617.1501(1) of the Florida Statutes. In pertinent part, Sections 617.1501(2)(f) and (g) of the Florida Statutes state the following:

... The following activities, among others, do not constitute *conducting affairs* within the meaning of [617.1501] subsection (1):

Ms. Diane Cushing April 11, 2003 Page 2

- (f) Creating or acquiring indebtedness, mortgages, and security interests in real personal property; and
- (g) Securing or collecting debts or enforcing mortgages and security interests in property securing the debt.

Because NSF helps borrowers with respect to their homes and mortgages, NSF believed, and continues to do so, that its activities fall under Sections 617.1501(2)(f) and (g) and thus do not constitute "conducting affairs" for the purpose of 617.1501(1). Thus, NSF felt it was not required to procure a certificate of authority from the Department of State. Nevertheless, once NSF was informed it was in fact required to obtain such a certificate, it immediately applied for such authorization.

NSF is a non-profit corporation with only moderate funds dedicated to licensing issues. NSF would like to resolve this matter without conflict. Consequently, NSF respectfully requests a ruling from your office on whether its activities in Florida constitute "conducting affairs" under Sections 617.1501(1) and (2)(f) and (g). In the event that you determine that NSF's activities do constitute "conducting affairs", I would like to ask whether your office would be willing to reduce the monies owed to an amount that NSF can readily pay in order to bring this matter to a resolution.


