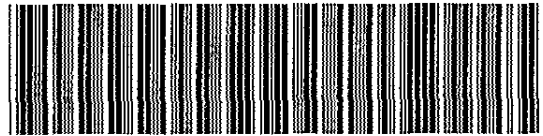

Your letter of July 2, 2003 states that, based on information provided by the Florida Department of Revenue. . . , it appears that AmerInd has transacted business in Florida prior to submitting an "Application for Authority to Transact Business in Florida." You identified an amount due of \$11,665.00 to cover annual report/uniform business report fees and penalties.

I confirm that AmerInd has operated in Florida since October 1, 1993 under an Occupational License issued by Escambia County, Florida. We have paid Florida Corporate Income Tax, Florida Sales and Use Tax, Florida State Unemployment Tax, Florida Intangible Personal Property Tax and Tangible Personal Property Tax in Escambia County. In the course of doing business in Florida for ten years, neither the Department of Revenue nor Escambia County identified the need to submit an "Application for Authority to Transact Business in Florida". Although more thorough research or foreign representation would have identified this requirement, it was not AmerInd's intent to avoid payment of fees. Accordingly, as a small business, we ask that the penalty be waived.
